THE PURPOSE OF ROVER'S PLAYHOUSE is to provide a safe, fun and stimulating social environment for dogs during weekday business hours. To ensure the safety and health of your pet and our other guests, we require all guests to comply with the following rules and regulations:

AGE: All dogs must be at least 12 weeks of age or older

SEX: All dogs 7 months or older must be spayed or neutered.

HEALTH: All dogs must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable condition in the last 30 days. Upon admission, all dogs must be free from any condition that could potentially jeopardize other guests. Dogs that have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted.

BEHAVIOR: All dogs must be non-aggressive and not food or toy protective. Owners will certify their dog(s) have not harmed or shown any aggressive or threatening behavior toward any person or any other dog(s). Please remember that your pet will be spending time with other pets and the safety and health of all animals is our main concern.

FEES:(as of 1/19/09) Fees for Daycare are based on a pass plan valid for 6 months from date of purchase.

One Day Pass: \$20.00
Five Day Pass: \$95.00 (\$19.00 per day)
Ten Day Pass: \$180.00 (\$18.00 per day)
Twenty Day Pass: \$340.00 (\$17.00 per day)

Additional dogs from same family are \$16.00 per day, per dog.

Half days: \$16.00 per day (four hours or less)

DAYCARE HOURS: Monday through Friday from 7:00 am to 6:30 pm

Reservations are suggested but not required

DOG BOARDING: RESERVATIONS REQUIRED

(2 night minimum on Holidays with 24 hour cancellation required or fees apply)

Daycare rate as noted above plus \$10.00/night/dog. Extra Large Kennels - \$15/night

Long Term Boarding Rate: (Boarding passes valid for 1 year from date of purchase)

7 Days/7 nights \$196.00 (\$28/day)

14 Days/14 nights \$378.00 (\$27/day)

30 Days/30 nights \$750.00 (\$25/day)

Monday through Friday from 7:00 am to 6:30 pm

Saturday and Sunday (Pick-up & Drop-off times 10am-11am & 6pm-7pm ONLY)

Reservations are required

CAT CONDO BOARDING: \$16/Day (Additional cat same family \$14/day)

FRIENDLY REMINDERS:

- ALL DOGS MUST HAVE AN "ID" TAG ON THEIR COLLAR OR FEES APPLY
 - VACCINATION INFORMATION IS REQUIRED BEFORE DAYCARE OR BOARDING WILL BE ALLOWED
 - Boarders need to bring in their own food
- Dog Vaccines required: (Rabies; Parvo/Distemper & Bordetella for Kennel Cough)

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending Rover's Playhouse.
2. I further understand and agree that in admitting my dog(s) to Rover's Playhouse, Rover's staff have relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
3. I further understand and agree that Rover's Playhouse and their staff will not be liable for any problems which develop, reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation at Rover's Playhouse.
4. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed best by staff of Rover's Playhouse at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
5. We reserve the right to refuse/cancel existing service if deemed necessary.
6. We reserve the right to use the following barking deterrents as deemed necessary: spray water bottle or a calming band.
7. A 2-night minimum stay is required for the following holidays with a 24 hour cancellation notice required or fees may apply (New Years Eve, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas)
8. Rover's Playhouse does not allow any dogs into Daycare or Boarding if they are over seven months and not yet neutered or spayed.
9. I understand that my dog must have a name tag and quick release snap collar or fees apply.

I certify that I have read and understand the policies of Rover's Playhouse set forth on the preceding pages and that I have read and understand the conditions, and statements of this agreement, including the following:

FEES: All fees are payable upon pickup. Daycare and Boarding passes are available. Daycare Passes are valid for 6 months from date of purchase and Boarding Passes are valid for 1 year from date of purchase. All passes are non-refundable but are transferable.

DAYS AND HOURS: Daycare pickup & drop-off times: Monday through Friday 7am to 6:30pm.
Weekend boarding pickup & drop-off times: Saturday & Sunday: 10-11am and 6-7pm

DAYCARE ATTENDEES are strongly encouraged to come on a regular basis, at least 1-2 times per week. We know from experience that this is going to help your dog adjust more easily to our routine and the pack. In addition, reservations are required.
